## 2025 TCS New York City Marathon - Agreement and Understanding

**Application Deadline**: April 15, 2025

#### **Runner Commitments:**

By participating, runners agree to the following obligations:

- **Fundraising Minimum**: Raise at least \$4,000 for the American Neuromuscular Foundation (ANF). The final fundraising amount is due by Monday, November 3, 2025.
  - o If the minimum is not met, the runner is responsible for paying the difference.
- **Travel Arrangements**: Arrange and cover the cost of personal travel and accommodations.
- **Event Registration Fee**: Pay the \$315 race registration fee by September 9, 2025, directly to the NYC Marathon NYRR using the invitation code provided on the NYRR event registration website.
- **ANF Apparel**: Share photos wearing the ANF-provided apparel.
- **Social Medial Consent**: Allow ANF/AANEM to share content posted on any of your social media platforms.
- **AANEM Annual Meeting**: -Participate in any ANF events during the annual meeting to help promote the ANF Charity Team and raise awareness (if attending the meeting).
- **Training Commitment**: Dedicate adequate time and effort to train for the event.

#### **Runner Benefits:**

- Guaranteed Entry: Secured spot in the 2025 TCS New York City Marathon.
  - o No race bib lottery (only 12% of lottery entrants are typically accepted).
  - o No time qualification requirement.
- ANF Support:
  - o Receive an ANF-branded shirt, donate button, and business cards with QR code to your personalized fundraising webpage.

- o Personalized Social Media Tool Kit.
- o Access to a personalized fundraising webpage with IT support.
- Promotion of your participation and fundraising efforts through ANF/AANEM communication channels.
- o ANF covers the \$600 bib fee for each runner.
- o **Impact**: Support groundbreaking neuromuscular research while increasing awareness and support for the ANF.

### Declaration:

By submitting my application and being approved to participate, I pledge to:

- Raise a minimum of \$4,000 for the ANF by November 3, 2025. I understand the ANF reserves the right to remove me as an entrant if I do not meet this obligation. If removed, I forfeit my entrance fee, and any funds raised will remain with the ANF.
- Accept responsibility for paying the difference if my fundraising minimum is not met by the deadline, unless alternate arrangements are made with ANF staff.
- Refrain from canceling or deferring participation without prior approval from the ANF. If
  I am unable to run for any reason, including injury, I am still obligated to meet the
  fundraising minimum.

# **Event Cancellation Policy:**

In the event the marathon is canceled due to unforeseen circumstances (e.g., acts of God, terrorism, severe weather, pandemic, or any other reason determined by the NYC Marathon organizers), I understand:

- Registration fees paid to the NYC Marathon are non-refundable.
- Any donations collected as of the cancellation date will remain with the ANF.
- ANF is not guaranteed entry into the NYC Marathon the following year; therefore, my participation in a subsequent race is not assured.
